M/S-Kiker/Horne— That the Moore County Airport Authority accept the Grant Modification for Project #36244.57.13.1 — Runway, Taxiway, and Apron Lights & Airfield Signage; and allocate funds in consideration of the local match requirement; and direct Director Maness to provide information about budget for this match.

H. Old Business

 Terminal Refresh – Airport Director Maness provided an update on work to be performed for the terminal refresh project. There was a discussion about adding a bathroom remodel to the scope of work. However, adding a bathroom remodel will increase the cost of the project. \$100,000 was allocated for this project. It was suggested that money reserved for power outages in the amount of \$50,000 be reallocated for the refresh project, for a new total amount of \$150,000.

M/S-Kiker/Horne—That the Moore County Airport Authority allow Airport Director Maness to begin work on the refresh project; and allocate \$150,000 for the project.

1. Projects Reports, Summaries and Updates

- Airport Director Maness informed the Authority that the new hangars opened on April 20, after yellow striping was completed. Two executive hangars have not been rented yet. The new T-hangar doors are designed in a specific way that will require tenants to be aware of the new process to open/close the doors.
- 2. Fred Smith will begin the Site Prep for the Taxilane, a \$650,000 project.
- 3. On Wednesday, April 26, at 1:30 p.m., Vice Chair Kiker, Treasure McPherson and Airport Director Maness will interview a candidate.
